

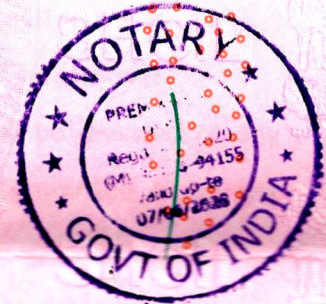

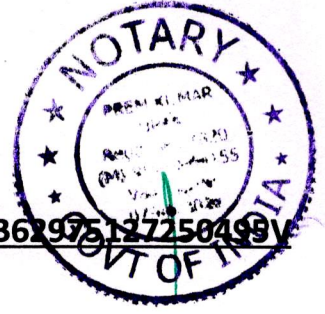

**AFFIDAVIT**

- 7) That the Principal and Correspondent/Manager of the school have individually gone through provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws directions issued from time to time and the law of the land.
- 8) That the school will ensure compliance of all statutory requirements like EPF, ESI and labour laws etc with respect to the school & staff of the school.
